

How to register as a Private Attorney for Securus Video Visitation Sessions

I recommend each Public Defender set up an individual account. To create individual accounts, they must use a phone number unique to them. Note: Public Defenders should not use the main office number as our system does not allow duplicate accounts for the same phone number.

After the Securus account is created, the Public Defender must submit a request to have access to HRRJ video visitation system as a "Private Attorney." The Public Defender will be required to upload a picture of themselves, their government ID, and their bar card.

Once HRRJ approves the request in our video system, the Public Defender will receive an email notification that they may start scheduling visits.

Below are the steps to create a Securus Video Visitation "Private Attorney" account at HRRJ:

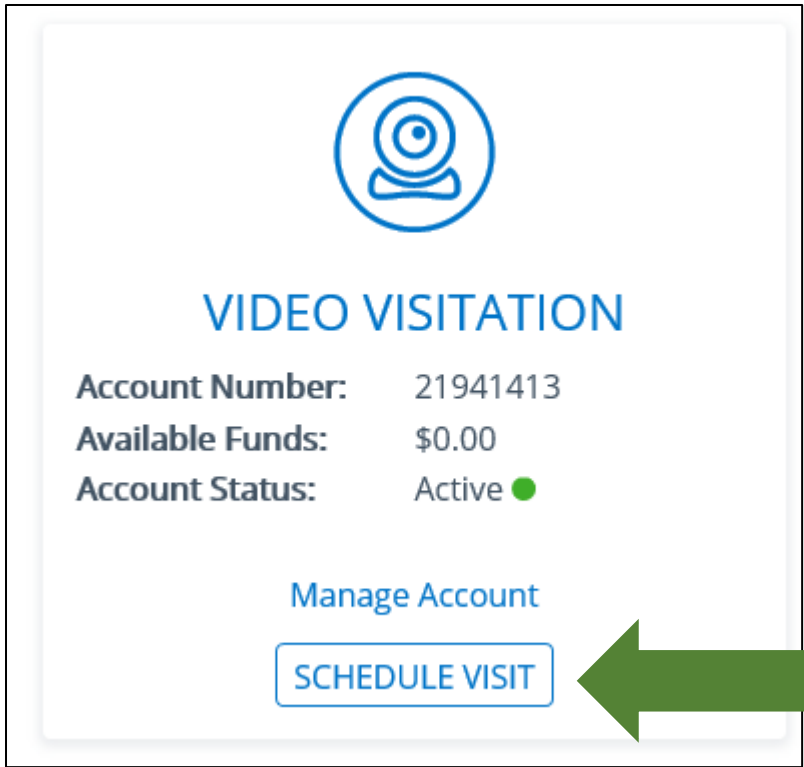
If your incarcerated loved one is located at a facility with Securus Video Visitation you can visit from anywhere using a smartphone or tablet.

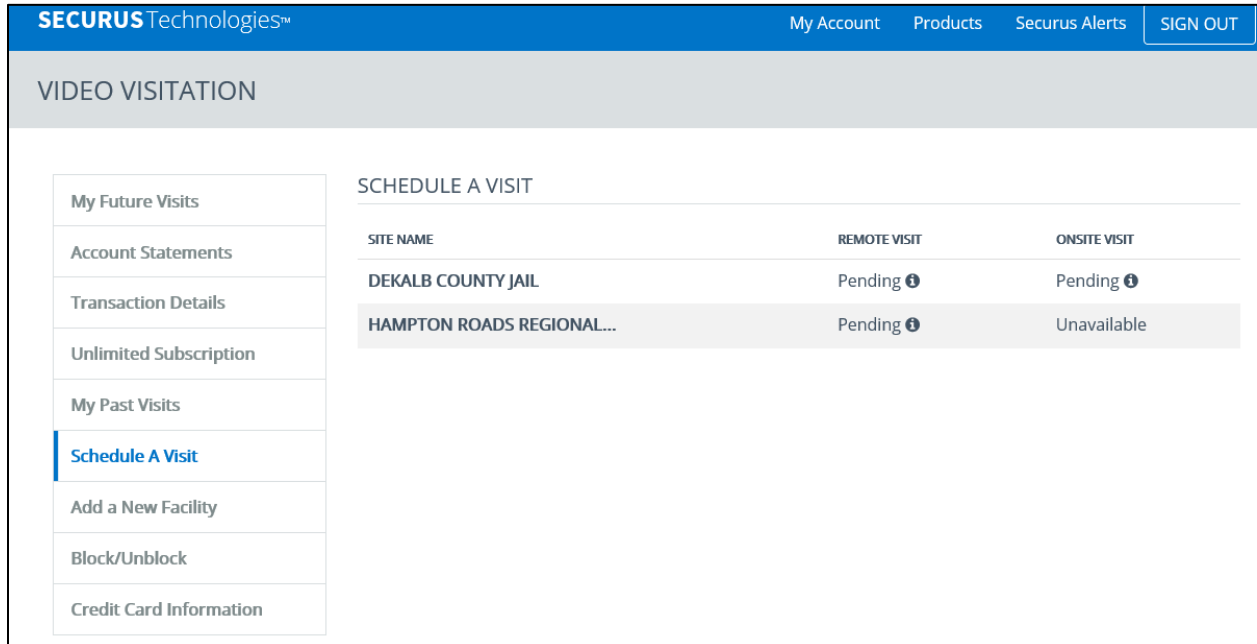

The Public Defender will not be able to schedule remote sessions until after HRRJ approves them as a “Private Attorney” at their facility. Once approved by HRRJ, the Public Defender may start scheduling remote sessions. Please note: Sessions must be made 24 hours in advance.



Once HRRJ approves the Public Defender as a “Private Attorney”, sessions will be set to non-record at this facility and the Public Defender can start scheduling remote sessions.

Please note: All inmate telephone calls are subject to monitoring and recording, unless an Attorney submits a request to the jail to set a specific telephone number to “private.”
